No. 143. The Tree Planting Village Areas Laws, 1930 to 1936.

NOTIFICATION UNDER SECTION 19A. Kato Amiandos (Limassol) Fund.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Kato Amiandos, in the District of Limassol, (hereinafter called the "Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Kato Amiandos, as described in the Order of the Governor made the 5th June, 1937, and published in the Gazette of the 11th June, 1937.

The Fund shall be under the management and control of the Commissioner of Limassol for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Kato Amiandos.
