ORDER IN COUNCIL No. 1728

MADE UNDER SECTION 65 (d).

In exercise of the powers vested in him by section 65 (d) of the Customs Law, 1936, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows:—

1. This Order may be cited as the Wharfage Dues (Importation of Herrings) Order, 1937.
2. From and after the 1st day of November, 1936, wharfage dues for imports at the special rates set forth in the Schedule hereto shall be levied upon herrings landed at any port in the Colony.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Arsos, in the District of Limassol, on the 12th day of July, 1936, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Arsos:

And whereas at the said meeting the boundaries of the said area have been fixed and described:

And whereas the Mukhtar of the village of Arsos has forwarded to the Commissioner of the District of Limassol a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Arsos.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Arsos in the District of Limassol.

#### SCHEDULE.

The area lying within the following boundaries, that is to say:—

The boundary begins at the most western point of plot No. 102, plan No. XLVI/39, locality "Kouphos," and goes north-eastwards along the northern boundaries of plots Nos. 102 and 101 of the same plan, plots Nos. 144, 145, 141, 140, 59, 58, plan No. XLVI/40, to the most northern point of plot No. 58, on a stream; thence southwards along the right bank of this stream to the south-eastern corner of plot No. 200 of the same plan, locality "Khomatos"; thence eastwards, passing along the boundaries of, and including in the reserved area, plots Nos. 200, 199, 198, 197, 263, 265, 419, 418, 427, 422 of the same plan, to the most western point of plot No. 422, on the road from the village of Arsos to Limassol; thence eastwards and south-westwards, along this road, to the fork of roads at the south-eastern corner of plot No. 136, plan No. XLVI/48, locality "Vasilakena"; thence south-westwards, along the other road, to the south-eastern corner of plot No. 157 of the same plan, locality "Vounos"; thence westwards, passing along the boundaries of, and including in the reserved area, plots Nos. 157, 155, 154 of the same plan, plots Nos. 359, 363, 362, 366, 365, 364, 410, 411, 412, 413, 414, 445, 444, 443, 431, 430, 433, 434, 423, 331, 327, 326, 236, 238, plan No. XLVI/47, locality "Vyzatjia," to the most northern point of plot No. 238, on a road to the village of Arsos; thence south-eastwards and north-eastwards, along this road, to the most southern point of plot No. 266, plan No. XLVI/39, locality "Khomatos," thence north-westwards and north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 266, 241 of the same plan, plots Nos. 206, 161, 160, 158, 157, plan No. XLVI/40, plots Nos. 103, 102, plan No. XLVI/39, to the starting point.

The area reserved comprises 1,793 donums approximately, as shown edged in red on plan filed in D.L.R.S. M.P. 511/36.
