No. 158. THE CUSTOMS LAW, 1936.

ORDER IN COUNCIL No. 1756

In exercise of the powers vested in him by section 65 (d) of the Customs Law, 1936, His Excellency the Governor, with the advice of the Executive Council, is pleased to order and it is hereby ordered as follows :—

1. This Order may be cited as the Wharfage Dues (Export of Hemp) Order, 1937.

2. Wharfage dues for exports at the special rate of two piastres per package shall be levied upon hemp exported from any port in the Colony.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

H. R. PALMER,

Governor.

Whereas at a meeting duly convened and held at the village of Ayia Varvara, in the District of Nicosia, on the 24th day of January, 1937, ^{it} was determined by the requisite majority of the voters present thereat that three areas should be reserved as the Tree Planting Area of the village of Ayia Varvara :

And whereas at the said meeting the boundaries of the said areas have been fixed and described :

And whereas the Mukhtar of the village of Ayia Varvara has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said areas and stating that the said areas fulfil the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the areas in the said report described should be reserved as the Tree Planting Area of the village of Ayia Varvara.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :---

The areas described in the Schedule hereto are hereby declared to be and shall be reserved as the Tree Planting Area of the village of Ayia Varvara in the District of Nicosia.

SCHEDULE.

The areas lying within the following boundaries, that is to say:-

The boundary begins at that point on the northern boundary of plot No. 110 of the Government Survey plan No. XXXIX/14 at which the boundary of the village of Ayia Varvara leaves the right bank of the river "Yialias," locality "Asprokremnos"; thence the boundary proceeds south-eastwards and north-eastwards along the said village boundary to the most northern point of plot No. 620 of the said plan, locality "Kokkinoi," on a footpath; thence eastwards along this footpath, excluding plot No. 652 of the said plan, to the most eastern point of plot No. 558 of the said plan, locality "Kokkinoyia"; thence south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 558, 559, 545, 544, 542, 528, 496, 518 (partly), 506, 508, 500, 391, 392, 396, 406, 407, 289, 297, 296, 295, 265, 264, 218, 217, 206, 207, 208, 146 of the said plan, plots Nos. 257, 256 and 255 of the Government Survey plan No. XXXIX/22, locality "Asproyi," to the most southern point of plot No. 255, on the boundary of the village of Ayia Varvara ; thence north-westwards and westwards along this village boundary to the most western point of plot No. 189 of the Government Survey plan No. XXXIX/13, locality "Kourka," on the right bank of the river "Yialias"; thence north-eastwards and eastwards along this bank of this river to the starting point.

AREA "B":

The boundary begins at the most northern point of plot No. 305 of the Government Survey plan No. XXXIX/6, locality "Poupes," on the boundary of the village of Ayia Varvara, and goes south-eastwards, north-eastwards and south-westwards through the localities "Makria Rakhi," "Paleomandres" and "Athkiatzera" to the most southern point of plot No. 381 of the Government Survey plan No. XXXIX/15; thence north-westwards and south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 381, 383, 384, 412, 409, 408, 414, 417, 365, 364, 362, 361, 359, 358, 356, 353, 351, 344, 342, and 341 of the said plan to the most southern point of plot No. 341, on the road from the village of Alambra to the village of Ayia Varvara ; thence westwards along this road to its junction with the road from the village of Ayia Varvara to the village of Pera Khorio, at the most western point of plot No. 271, locality "Skoullena"; thence north-eastwards along the latter road to its junction with another road at the most southern point of plot No. 88 of the said plan, locality "Throumberka"; thence south-westwards along the latter road to the most southern point of the threshing-floor, plot No. 1036, of the Government Survey plan No. XXXIX/14; thence north-westwards along a track to the most eastern point of plot No. 951 of the said plan; thence southwards, passing along the boundaries of, and including in the reserved area, plots Nos. 951, 952, 954, 966, 967, 968, 988, 989 and 978 of the said plan to the most southern point of plot No. 978, on the road from the village of Ayia Varvara to the village of Kochati; thence north-westwards along this road to the most western point of plot No. 301 of the Government Survey plan No. XXXIX/6, locality "Pouzes"; thence north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 301, 303 and 305, to the starting point.

AREA "C":

The boundary begins at the most northern point of plot No. 251 of the Government Survey plan No. XXXIX/22, on a track and on the boundary of the village of Ayia Varvara, and goes north-eastwards along this track to the said village, to the north-eastern corner of plot No. 1306 of the Government Survey plan No. XXXIX/14; thence southwards and south-westwards along the road to the village of Mathiati to the most southern point of plot No. 136 of the said plan, locality "Selladhia," on the boundary of the village of Ayia Varvara; thence northwards along this village boundary to the starting point.

The areas reserved comprise 4,248 donums approximately, as shown edged in red on the plan filed in D.L.R.S. M.P. 469/33.
