THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Louroujina, in the District of Nicosia, on the 29th day of August, 1937, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Louroujina :

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Louroujina has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Louroujina :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Louroujina in the District of Nicosia.

SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary begins at the most western point of plot No. 591, plan No. XL/2, locality " Xalona," on the road from the village of Louroujina to the main road from Nicosia to Larnaca, and goes eastwards along this road to the footpath at the most western point of plot No. 583, plan No. XL/3, locality " Moutsounin " ; thence south-eastwards along this footpath to the rocky slope on plot No. 297, plan No. XL/11 ; thence south-eastwards along the top of this slope as far as the main road from Nicosia to Larnaca ; thence south-eastwards along this main road to the most southern point of plot No. 373 of the same plan, on a track ; thence north-eastwards along this track to the most eastern point of plot No. 11, plan No. XL/12, locality " Phoradhomandra," which point is on the boundary of the village of Louroujina ; thence south-westwards and north-westwards along this village boundary as far as the most southern point of plot No. 67, plan No. XL/10, locality " Vodhonostrata," on a footpath ; thence north-westwards and eastwards along this footpath leaving to the reserved area part of plot No. 66, plots Nos. 67, 73, 74, 75, 95, 96 of the same plan, plots Nos. 647, 597, 595, 596 and 591 of plan No. XL/2 to the starting point. The area reserved comprises 3,454 donums, be the same more or less, as shown on the plan filed in D.L.R.S. M.P. 331/37.
