THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Vavatsinia, in the District of Larnaca, on the 18th day of July, 1937, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Vavatsinia :

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Vavatsinia has forwarded to the Commissioner of the District of Larnaca a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the Village of Vavatsinia.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Vavatsinia in the District of Larnaca.

SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary begins at the north-western corner of plot No. 134, plan No. XLIX/1, locality "Karvounarka," which point is on the boundary of the village of Vavatsinia, and goes north-eastwards, south-eastwards and south-westwards along this village boundary to the south-eastern corner of plot No. 18, plan No. XLIX/10, locality "Koleas," on the main road from the village of Vavatsinia to the village of Lefkara ; thence north-westwards along this road to the south-eastern corner of plot No. 8 of the same plan ; thence north-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 201 and 198, plan No. XLIX/2, to the stream at the most eastern point of plot No. 192 of the same plan ; thence north-westwards down this stream to the most southern point of plot No. 130 of the same plan, locality "Koplatani" ; thence north-westwards along the western boundary of this plot to its north-western corner, on a stream ; thence eastwards up this stream to the most western corner of plot No. 168 of the same plan, locality "Laoni" ; thence north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 168, 99, 232.7 to the most northern point of plot No. 232.7 of the same plan ; thence eastwards in a straight line across plot No. 232.5 to the most northern point of plot No. 92 of the same plan ; thence north-eastwards passing

along the boundaries of, and including in the reserved area, plots Nos. 92, 91, 85, 82, 79, 78 of the same plan to the stream at the most northern point of plot No. 78 of the same plan, locality "Perveles"; thence north-westwards down this stream to the most northern point of plot No. 64 of the same plan; thence south-westwards in a straight line to the most eastern point of plot No. 54 of the same plan; thence westwards along the northern boundary of plot No. 54 of the same plan to its north-western corner; thence westwards in a straight line across plot No. 71 to the most southern point of plot No. 17 of the same plan; thence north-westwards along the southern boundary of plot No. 17 to its most western point, on a stream; thence northwards down this stream to its junction with another stream at the most northern point of plot No. 20 of the same plan, locality "Kourtellorotsos"; thence westwards along the latter stream to the most eastern point of plot No. 32, plan No. XLIX/1, where it is joined by another stream; thence south-westwards up the latter stream as far as the most southern point of plot No. 28 of the same plan; thence westwards in a straight line across plot No. 134 of the same plan to the north-eastern corner of plot No. 15 of the same plan; thence westwards along the northern boundary of plot No. 15 to its north-western corner; thence westwards in a straight line across plot No. 134 of the same plan to the most northern point of plot No. 14 of the same plan, on a footpath; thence north-westwards along this footpath to the most northern point of plot No. 13 of the same plan; thence westwards along the northern boundary of plot No. 12 of the same plan to its most western point; thence westwards in a straight line across plot No. 134 of the same plan to the most southern point of plot No. 473 of the same plan, locality "Karvounarka"; thence westwards passing along the boundaries of, and including in the reserved area, plots Nos. 473 and 1 of the same plan, plots Nos. 330, 333 and 335, plan No. XLVIII/8, to the most western point of plot No. 335 of the same plan; thence westwards in a straight line across plot No. 134, plan No. XLIX/1, to the most eastern point of plot No. 148, plan No. XLVIII/8, locality "Karvounarka"; thence northwards along the eastern boundary of plot No. 148 of the same plan to the starting point.

The area reserved comprises 1,818 donums approximately, as shown on the map filed in D.L.R.S. M.P. 457/37.
