

which point is on the boundary of the village of Ayios Epiktitos, and goes eastwards and north-eastwards along the boundaries of, and including in the reserved area, plots Nos. 124, 125, 129, 135, 137, 138, 140, 139, 141, 143, 154/1, 154, 346, 355, 353, 349, 351, 351/1, 359, 360, 361, 367, 366/1, 366/2, 369, 368/1, 373, 374 and 375, to the most eastern point of plot No. 375 of the same plan, on the left bank of the river "Jirkou"; thence southwards along the left bank of this river to the most southern point of plot No. 484, of the Government Survey plan No. XII/31, locality "Alonia"; thence north-westwards along the southern boundaries of plots Nos. 484 and 483 of the same plan, to the road leading from the village of Ayios Epiktitos to the locality "Jirkou"; thence along the eastern side of this road as far as the north-western corner of plot No. 482 of the same plan; thence westwards and northwards along the boundaries of plot No. 480 of the same plan, plots Nos. 248 and 247/1, of the Government Survey plan No. XII/23, plots Nos. 478, 475 and 477 to the most northern point of plot No. 477 of the same plan, which point is on the road leading from the village of Ayios Epiktitos to the locality "Jirkou"; thence southwards along the western side of this road to the most northern point of plot No. 461 of the same plan, locality "Phtana"; thence south-westwards along the boundaries of plots Nos. 477, 476, 465, 447, 446, to the most southern point of plot No. 446 of the same plan, which point is on the main road from the village of Ayios Epiktitos to Kyrenia; thence north-westwards along this main road to the north-eastern corner of plot No. 402 of the same plan; thence westwards and south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 405, 404, 403, 399, 398, 395, 196 to the ridge at the most western point of plot No. 377 of the same plan; thence westwards along this ridge as far as the eastern boundary of plot No. 198 of the same plan; thence northwards along the boundaries of, and including in the reserved area, plots Nos. 197, 200, 199, 202, 203, 207, to the most northern point of plot No. 206 of the same plan, on a ridge; thence westwards along this ridge, through plot No. 214 of the same plan, to the most eastern point of plot No. 60 of the same plan, which point is on the boundary of the village of Ayios Epiktitos; thence northwards along this village boundary to the point of commencement.

The area reserved comprises 1,029 donums approximately, as shown edged in red on the plan filed in D.L.R.S. M.P. 383/37.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Pano Lefkara, in the District of Larnaca, on the 18th April, 1937, it was determined by the requisite majority of the voters present thereat that a certain area (hereinafter called "the additional area") should be

reserved as a Tree Planting Area of the village of Pano Lefkara in addition to the Tree Planting Area of the village of Pano Lefkara reserved by an Order of His Excellency the Governor and published in the *Gazette* of the 19th of June, 1936, under Notification No. 585 (hereinafter called "the original area") :

And whereas at the said meeting the boundaries of the said additional area have been fixed and prescribed :

And whereas the Mukhtar of the village of Pano Lefkara has forwarded to the Commissioner of the District of Larnaca a report signed and sealed by him containing a description with boundaries and particulars of the said additional area stating that such area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report with his recommendations to the Colonial Secretary for the consideration of the Governor.

And whereas the Governor is satisfied that the original area and the additional area taken together do not comprise in the aggregate more than one-quarter of the total extent of the Arazi Mirié lands situated within the limits of the village of Pano Lefkara :

And whereas the Governor has been pleased to approve the report and considers it expedient, having regard to all the circumstances that the said additional area should be reserved as a Tree Planting Area of the village of Pano Lefkara in addition to the original area :

And whereas the Governor for good cause shown has decided to abridge the period mentioned in section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936 :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

1. The area described in the Schedule hereto is hereby declared to be and shall be reserved as a Tree Planting Area of the village of Pano Lefkara in the District of Larnaca in addition to the original area.
2. The period mentioned in section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936, is hereby and shall be abridged to expire on the 19th July, 1946.

SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary begins at the most western point of plot No. 477, plan No. XLIX/20, locality "Pamboula," on the road from the village of Pano Lefkara to Nicosia, and goes north-eastwards along this road to the most northern point of plot No. 148 of the same plan, locality "Pezounokremmos"; thence south-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 148, 149, 132, 130, 519, 128, 127, 125, 124, 527, 529, 530 of the same plan, locality "Mutti-Vikli," plots Nos. 64, 66, 72, plan No. XLIX/21, to the south-western corner of plot No. 534, plan No. XLIX/20, locality "Vikles," on a footpath; thence south-westwards along this footpath to the most southern point of plot No. 584 of the same plan, locality "Ambela," which point

is on the boundary of the village of Pano Lefkara; thence south-westwards and south-eastwards along this village boundary to the most eastern point of plot No. 588, plan No. XLIX/29, locality "Ayios Yeorghios"; thence south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 588, 596, 595, 799, 797, 802 of the same plan, locality "Paounaros," plot No. 785, plan No. XLIX/28, to the south-western corner of plot No. 785 of the same plan, on the road from Zyzi to the village of Pano Lefkara; thence north-westwards along this road to the most western point of plot No. 646 of the same plan, locality "Plevres"; thence north-eastwards and northwards passing along the boundaries of, and including in the reserved area, plots Nos. 646, 647, 636, 637, 638 and 642 of the same plan to the most southern point of plot No. 642 of the same plan, on the road from Zyzi to the village of Pano Lefkara; thence along this road to the most western point of plot No. 639 of the same plan; thence north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 639, 638, 627, 628 of the same plan, plots Nos. 881, 683, 682, plan No. XLIX/20, to the most northern point of plot No. 682 of the same plan; thence north-eastwards crossing plot No. 676 (hali land) in a straight line to the most western point of plot No. 675 of the same plan; thence north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 675, 674, 618, 617, 630, 631, 611, 610, 897.2, 897.1, 605, 601, 509, 508, 507, 506, 505, 458, 457, 461, 449, 448, 447 and 477 of the same plan to the starting point.

The area reserved comprises 1,135 donums approximately, as shown on the plan filed in D.L.R.S. M.P. 195/36.

THE ANTIQUITIES LAW, 1935,

AND

THE LAND ACQUISITION LAWS, 1899 TO 1936.

Whereas His Excellency the Governor is satisfied that in order to preserve the amenities of the ancient monuments in the Famagusta District set out as items 3 and 31 in the First Schedule and items 10 and 24 in the Second Schedule of the Antiquities Law, 1935, it is desirable that no building should be erected in the proximity of such ancient monuments upon the plots of land described in the Schedule hereto and that any buildings thereon should be demolished:

Now, therefore, in exercise of the power vested in him by section 12 of the Antiquities Law, 1935, His Excellency the Governor is pleased to direct and hereby directs that the plots of land and the buildings described in the Schedule hereto be acquired on payment of such amount by way of compensation as may be agreed upon between the Commissioner of Famagusta and the proprietor of the said plots of land and the buildings and that in default of agreement within one month from the date hereof the amount of compensation be determined in accordance with the provisions of the Land Acquisition Laws, 1899 to 1936.
