REGULATIONS MADE UNDER SECTION 14.

H. R. PALMER,

Governor.

In exercise of the powers vested in him by section 14 of the Trades and Industries (Regulation) Law, 1937, His Excellency the Governor, with the advice of the Executive Council, is pleased to make and hereby makes the following regulations:—

- 1. These Regulations may be cited as the Regulated Trades (Forms and Fees) Regulations, 1937.
- 2. The Register of Regulated Trade Premises to be kept by the Commissioner shall be in the form and shall contain the particulars set out in the First Schedule hereto.
- 3. Every application for the registration of premises shall be in the form and shall contain the particulars set out in the Second Schedule hereto.
- 4. The certificate of the Director of Medical Services or of his duly authorized representative required by section 7 of the Law to accompany every application for the registration of premises shall be in the form set out in the Third Schedule hereto.
- 5. The certificate of the Director of Public Works or of his duly authorized representative required by section 7 of the Law to accompany every application for the registration of premises shall be in the form set out in the Fourth Schedule hereto.
- 6. The certificate of registration to be issued by the Commissioner under section 9 of the Law shall be in the form set out in the Fifth Schedule hereto.
- 7. The fee to be charged in respect of every certificate of registration shall be one shilling and shall be payable in cash to the Commissioner at the time of the issue of the certificate.
- 8. These Regulations shall come into operation on the 1st day of January, 1938.
