interest not exceeding five per centum (5%) per annum repayable by the Municipal Corporation in fifteen (15) equal annual instalments (comprising sinking fund and interest).

- 2. That the Municipal Corporation shall in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenues the annual instalment repayable in the year to which such estimates relate.
- 3. That the sum borrowed shall be utilized by the Municipal Corporation for the purpose of asphalting the streets of Famagusta.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

H. R. PALMER, Governor.

Whereas at a meeting duly convened and held at the village of Larnaka tis Lapithou, in the District of Kyrenia, on the 5th day of April, 1936, it was determined by the voters present thereat that three areas should be reserved as the Tree Planting Area of the village of Larnaka tis Lapithou.

And whereas at the said meeting the boundaries of the said areas have been fixed and described :

And whereas the Mukhtar of the village of Larnaka tis Lapithou has forwarded to the Commissioner of the District of Kyrenia a report, signed and sealed by him, containing a description with boundaries of the said areas and stating that the said areas fulfil the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the areas in the said report described should be reserved as the Tree Planting Area of the village of Larnaka tis Lapithou:

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The areas described in the Schedule hereto are hereby declared to be and shall be reserved as the Tree Planting Area of the village of Larnaka tis Lapithou in the District of Kyrenia.

#### SCHEDULE.

The areas lying within the following boundaries, that is to say:—

Area "A":

The boundary begins at the most northern point of plot No. 2, plan No. XI/30, locality "Pallourka," and goes eastwards and south-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 2, 6, 7, 8, 9, 10 of the same plan to the forest delimitation line of Lapithos and Karavas Forest, which forms part of the northern boundary of plot No. 10; thence southeastwards along this forest delimitation line to the north-eastern corner of plot No. 115 of the same plan, locality "Skalin tou Lonikou," on the boundary of the village of Larnaka tis Lapithou; thence south-westwards and south-eastwards, along this village boundary, to the most southern point of plot No. 110 of the same plan; thence westwards, passing along the boundaries of, and including in the reserved area, plots Nos. 110, 112, 117, 116, 118, 120, 132/2 of the same plan, locality "Scales," plots Nos. 122, 123, 126, 31, 29, 28, locality "Petra tou Stavrinou," plots Nos. 19 and 18 of the same plan, to the south-western corner of plot No. 18, on the forest delimitation line of Korphi Forest; thence northwestwards, along this forest delimitation line, to the most southern point of plot No. 2 of the same plan; thence north-westwards, along the western boundary of this plot, to the starting point.

#### AREA "B":

The boundary begins at the most northern point of plot No. 41, plan No. XI/29, locality "Kaminin," on the boundary of the village of Larnaka tis Lapithou and on a stream, and goes north-eastwards up this stream to the junction of streams at the north-western corner of plot No. 165 of the same plan, locality "Limni"; thence eastwards up one of these streams, along the northern boundary of this plot to its most northern point, on the road from the village of Vasilia to the village of Larnaka tis Lapithou; thence south-eastwards, along the western side of this road, to the most eastern point of plot No. 167 of the same plan, locality "Plaka," on a stream; thence south-westwards, down this stream, through the localities "Platania," "Khalandra," "Kuru Yiannidhes" and "Partashes" to the river "Oros," at the most southern point of plot No. 142, plan No. XI/37; thence westwards and north-westwards, down the right bank of this river, to the most southern point of plot No. 21, plan No. XI/29, locality "Tris Elies," on the boundary of the village of Larnaka tis Lapithou; thence northwards and eastwards, along this village boundary, to the starting point.

## AREA "C":

The boundary begins at the most northern point of plot No. 133, plan No. XI/37, locality "Gypsokamina," on the boundary of the village of Larnaka tis Lapithou and on the left bank of the river "Oros," and goes eastwards and southwards up the left bank of this river to the south-eastern corner of plot No. 155 of the same plan; thence north-westwards and south-westwards, passing along the boundaries of, and including in the reserved area, plots Nos. 155, 158, 159, 117, 117/1, 117/2, 117/3 of the same plan, to the most

eastern point of plot No. 117/3, locality "Groupia," on the boundary of the village of Larnaka tis Lapithou; thence south-westwards and north-westwards, along this village boundary through the locality "Sakhlambadhes," to the starting point.

The areas reserved comprise 1,516 donums approximately, as shown edged in red on the plans filed in the D.L.R.S. M.P. 253/36.

## Notification under the Tree Planting Village Areas Laws, 1930 to 1936.

ARMOU (PAPHOS) FUND.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Armou, in the District of Paphos, (hereinafter called the "Fund") into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Armou, as described in the Order of the Governor made the 30th December, 1936, and published in the Gazette of the 31st December, 1936.

The Fund shall be under the management and control of the Commissioner of Paphos for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Armou.
