THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

H. R. PALMER, Governor.

Whereas at a meeting duly convened and held at the village of Pelendria, in the District of Limassol, on the 26th day of July, 1936, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Pelendria:

And whereas at the said meeting the boundaries of the said area have been fixed and described:

And whereas the Mukhtar of the village of Pelendria has forwarded to the Commissioner of the District of Limassol a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Pelendria.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Pelendria in the District of Limassol.

## SCHEDULE.

The area lying within the following boundaries, that is to say:-The boundary begins at the most western point of plot No. 277, plan No. XXXVII/54, locality "Kardama," on the boundary of the village of Pelendria, and goes eastwards and southwards, along this village boundary, through the localities "Phournia" and "Psilo," to the south-eastern corner of plot No. 624, plan No. XXXVII/55, locality "Kaminia"; thence westwards XXXVII/55, and south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 624, 625, 627, 631, 600, 599, 656, 659 of the same plan to the most eastern point of plot No. 196, plan No. XXXVII/63, on a footpath; thence southwards, along this footpath, to the most southern point of plot No. 264 of the same plan, on the road from the village of Pelendria to the village of Kato Amiandos; thence north-westwards, crossing this road, to the most southern point of plot No. 242 of the same plan, on a footpath; thence north-westwards and south-westwards, along this footpath, to the most southern point of plot No. 441, plan No. XXXVII/62, locality "Marathos"; thence southwards, passing along the boundaries of, and including in the reserved area, plot No. 440 of the same plan, plots Nos. 46, 47, 54, 53, 57, 56, 61, 86, 89, 91, 92, 122, 124, 128, 138, 139, 140, 303, 301, 300, 296, 297, 293, 288, 289, 281, 280, 270, 279, 253, 254, plan No. XLVII/6, to the most southern point of plot No. 254, on the left bank of the river "Amiandos"; thence due south to the right bank of this river and south-eastwards and south-westwards along this bank of the river to the most western point of plot No. 92, plan No. XLVII/l4, locality "Moutti-tou-Arayiti"; thence north-eastwards, along the western boundaries of plots Nos. 92, 91 and 90 of the same plan, to the forest delimitation line; thence north-eastwards and northwestwards, along this forest delimitation line through Forest Cairns Nos. 124, 123, 122, 121, 120, 119, 118 (Troödos Forest); Forest Cairns Nos. 9, 8, 7, 6, 5, 4, 3, 2, 1 (Kakoyeros Forest); Forest Cairns Nos. 118, 117, 116, 115, 114, 113, 112, 111, 110 (Troödos Forest) to Forest Cairn No. 109, on the boundary of the village of Pelendria; thence north-westwards, along this village boundary, to the south-western corner of Kardama Forest; thence southeastwards, north-eastwards and north-westwards, along the forest delimitation line of this forest, through Forest Cairns Nos. 7, 6, 5, 4, 3, 2, and along the northern boundaries of plots Nos. 47 and 46, plan No. XXXVII/54, to the boundary of the village of Pelendria; thence north-eastwards, along this village boundary, to the starting point.

The area reserved comprises 4,568 donums approximately, as shown edged in red on the plan filed in D.L.R.S. M.P. 525/33.
