THE MUNICIPAL CORPORATIONS LAWS, 1930 AND 1934.

§ ORDER IN COUNCIL No. 1736

MADE UNDER SECTION 116 (a) (i).

*Authority to the Council of the Municipal Corporation of Paphos  
to contract a loan.*

In exercise of the powers vested in him by section 116 (a) (i) of the Municipal Corporations Laws, 1930 and 1934, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows:—

1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Paphos, (hereinafter referred to as "the Municipal Corporation"), shall be at liberty to borrow from the Ottoman Bank, (hereinafter referred to as "the lender"), the sum of one thousand and five hundred pounds (£1,500) at a rate of interest not exceeding five per centum (5%) per annum subject to the following terms and conditions, that is to say:—

(a) That the sum borrowed shall be repayable by the Municipal Corporation to the lender in fifteen annual instalments as follows, that is to say:—

(i) the first annual instalment shall represent only the interest payable on the sum borrowed;

(ii) the fourteen subsequent annual instalments shall be equal annual instalments and shall comprise sinking fund and interest.

(b) That interest at the rate of five per centum per annum shall be payable by the Municipal Corporation to the lender upon any instalment or any part thereof falling due and remaining unpaid.

(c) That the Municipal Corporation shall, in each year and until final payment of the sum borrowed, insert in the annual estimates as a charge on the revenues the annual instalment repayable in the year to which such estimates relate.

(d) That the sum borrowed shall be utilized by the Municipal Corporation for the following purposes:—

- (i) for the purchase of a combined fire-engine and water sprinkler and for the necessary housing and accessories;
- (ii) for the construction of a covered place in the Municipal Market;
- (iii) for the construction of new public latrines;
- (iv) for the opening, widening and asphaltting of streets;
- (v) for the improvement of the water distribution system.

2. For the purpose of securing the repayment of the said sum of one thousand and five hundred pounds the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.
