THE BURIALS LAW, 1896.

ORDER MADE UNDER SECTION 1.

H. R. PALMER, Governor,

Whereas the burial-ground situated in the village of Lefka, District of Nicosia, now in use by the Orthodox-Christian Community for the burial of the dead, is dangerous to the health of the said village:

Now, therefore, in exercise of the powers vested in him by section 1 of the Burials Law, 1896, His Excellency the Governor has been pleased to order and hereby orders that a new burial-ground, in substitution for the burial-ground now in use as aforesaid, shall be provided under the provisions of the said Law.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

H. R. PALMER, Governor.

Whereas at a meeting duly convened and held at the village of Philousa, in the District of Paphos, on the 9th day of February, 1936, it was determined by the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Philousa:

And whereas at the said meeting the boundaries of the said area

have been fixed and described:

And whereas the Mukhtar of the village of Philousa has forwarded to the Commissioner of the District of Paphos a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed:

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the

consideration of the Governor:

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Philousa.

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :-

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village

of Philousa in the District of Paphos.

SCHEDULE.

The area lying within the following boundaries, that is to say:-

The boundary begins at the north-western corner of plot No. 889, plan No. XLVI/30, locality "Skasmata," on a stream, and goes north-eastwards up this stream, passing along the boundaries of and including in the reserved area plot No. 889 of the same plan, plots Nos. 84, 83, 82, 81, 80, 79, 78, 77, 75 and 49, plan No. XLVI/31, locality "Lidjotika," plots Nos. 51, 52, 53 and 63 of the same plan, locality "Pertikosydjes," on the boundary of the village of Philousa; thence southwards and south-eastwards, along this village boundary, to the most western point of plot No. 325 of the same plan; thence south-westwards, passing along the boundaries of and including in the reserved area plots Nos. 290, 291, 295, 269, 270 of the same plan, locality "Kambos," plots Nos. 273, 274, 244, 221, 220, 200, 201, 202, 209, 208, 207 of the same plan, locality "Karchou," plots Nos. 206, 205, 204, 122, 123, 125, 126, and 127 of the same plan, locality "Djephalas," to the south-eastern corner of plot No. 127, on a track from the village of Philousa to "Ayios Nicolaos" Church; thence south-westwards and north-westwards, along this track, to the south-western corner of plot No. 948, plan No. XLVI/30, locality "Sarandies"; thence north-eastwards, passing along the boundaries of and including in the reserved area plots Nos. 948, 949, 950, 951, 952, 953, 940, 939, 935 of the same plan, locality "Tilliries," plots Nos. 895, 893, 891, 889 of the same plan to the starting point.

The area reserved comprises 397 donums approximately, as shown

edged in red on the plan filed in D.L.R.S. M.P. 150/36.

THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936. NOTIFICATION UNDER SECTION 19A.

Arsos (Limassol) Fund.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Arsos, in the District of Limassol, (hereinafter called the "Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Arsos, as described in the Order of the Governor made the 21st January, 1937, and published in the Gazette of the 22nd January, 1937.

The Fund shall be under the management and control of the Commissioner

of Limassol for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Arsos.
