No. 74. THE BURIALS LAW, 1896.

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 1175, published in the *Gazette* of the 4th October, 1935, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Christian Community of the village of Lapathos, in the District of Famagusta :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Law, 1896, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 1st day of May, 1937, no burial shall take place in the burial-ground in lieu whereof the new burialground above referred to has been provided.

Whereas it has been represented to me that it is desirable to widen those streets in the village of Trikomo in the District of Famagusta which form the chief means of communication between the said village and the village of Ardhana in the same District;

Now, therefore, I, Herbert Richmond Palmer, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, Governor and Commanderin-Chief in and over the Colony of Cyprus, in virtue of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1936, do hereby declare the widening of the streets, as aforesaid, to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Commissioner of Famagusta the supervision and effectuation of the said undertaking.

THE LAND ACQUISITION LAWS, 1899 TO 1936.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas it has been represented to me that it is desirable in the public interest to provide for the future building requirements of Government in the vicinity of Nicosia Town in the District of Nicosia :

Now, therefore, I, Herbert Richmond Palmer, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, Governor and Commanderin-Chief in and over the Colony of Cyprus by virtue of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1936, do hereby declare the acquisition of land in the vicinity of Nicosia Town, in the District of Nicosia, for the future building requirements of Government, the subsequent lay out of such land and the erection thereon of Government buildings for use as offices and otherwise to be an undertaking of public utility, and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Director of Land Registration and Surveys the supervision and effectuation of the said undertaking.

The Contagious Diseases (Animals) Law, 1880. Order under Section 2 (1) (l.).

In exercise of the powers vested in the Governor by section 2(1)(l.) of the Contagious Diseases (Animals) Law, 1880, duly deputed to me under section 4 of the said Law by paragraph 3 of the Notification No. 527 published in the *Gazette* of the 3rd July, 1931, I, Robert Jestin Roe, Chief Veterinary Officer, hereby order as follows :---

1. All sheep and goats in the Colony, with the exception of sheep and goats within the village areas of the villages set out in the schedule hereto, shall be inoculated with anthrax vaccine.

2. The inoculations shall be carried out by Veterinary Officers or by such Vaccinators as may be appointed by me in writing in that behalf.
