ORDER IN COUNCIL No. 1724

MADE UNDER \$ECTION 59.

H. R. PALMER, Governor.

In exercise of the powers vested in him by section 59 of the Customs Law, 1936, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows:—

- 1. This Order may be cited as the Prohibited Exports (Cotton Seed) Order, 1937.
- 2. From and after the date hereof the exportation of cotton seed is prohibited save under the authority of a licence granted by the Director of Agriculture and subject to such terms and conditions as may be prescribed in such licence.

## ORDER IN COUNCIL No. 1725

MADE UNDER SECTION 52.

H. R. PALMER, Governor.

In exercise of the powers vested in him by section 52 of the Customs Law, 1936, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows:—

1. This Order may be cited as the Import of Motor Lorries (Prohibition) Order, 1937.

- 2. The importation into the Colony of any motor lorry exceeding in size or capacity the standard 30 cwt. capacity type, or having a wheelbase exceeding 136 inches in length, or having twin rear wheels, is prohibited save under a licence under the hand of the Colonial Secretary and subject to such terms and conditions as may be prescribed in such licence.
- 3. The Order in Council No. 1506 of the 8th day of November, 1932, published in the *Gazette* of the 11th day of November, 1932, is hereby revoked.

THE QUARANTINE LAW, 1932. Regulations made under Section 6. Su 1, 61

H. R. PALMER,

Governor.

In exercise of the powers vested in him by section 6 of the Quarantine Law, 1932, His Excellency the Governor, with the advice of the Executive Council, is pleased to make and hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Quarantine (Public Health) Amendment Regulations, 1937, and shall be read as one with the Quarantine (Public Health) Regulations, 1935, (hereinafter called "the Principal Regulations"), and the Principal Regulations and these Regulations may together be cited as the Quarantine (Public Health) Regulations, 1935 and 1937.
- 2. Regulation 15 of the Principal Regulations is hereby repealed and the following Regulation substituted therefor:—
  - "15. In case of an outbreak of plague, cholera, typhus, smallpox, epidemic cerebro-spinal meningitis or diphtheria the Director of Medical Services or any Government Medical Officer authorized by him may order the evacuation of any house which in his opinion is within the range of infection or may order the isolation and keeping isolated of any town or village or part of any town or village, or any lane or street in any part of any town or village."
