Whereas His Excellency the Governor is satisfied that the properties described in the Schedule hereto and situated in the village of Episkopi, in the District of Limassol, at or near the localities "Ayrani" and "Palaeokastron" upon which excavations are being carried out by Bert Hodge Hill acting for and on behalf of the University Museum, University of Pennsylvania in Philadelphia, should be compulsorily acquired by the Government;

And whereas His Excellency the Governor, before notifying his sanction to the acquisition of the said properties or any of them, requires the value of such properties and the amount to be paid therefor by way of compensation to be first ascertained;

Now, therefore, in exercise of the powers vested in him by section 17 (2) of the Antiquities Law, 1935, and section 7 of the Land Acquisition Laws, 1899 to 1936, is pleased to direct and it is hereby directed that the Commissioner of Limassol shall proceed to ascertain the amount to be paid by way of compensation in respect of the properties described in the Schedule hereto in accordance with the provisions of the Land Acquisition Laws, 1899 to 1936.

2. The Notification No. 285 published in the Gazette of the 27th March, 1936, is hereby cancelled.
