THE CUSTOMS LAW, 1936.

ORDER IN COUNCIL No. 1739

MADE UNDER SECTION 52.

In exercise of the powers vested in him by section 52 of the Customs Law, 1936, His Excellency the Governor, with the advice of the Executive Council, is pleased to order and it is hereby ordered as follows :—

1. This Order may be cited as the Import Duty (Motor Vehicles of Officers of His Majesty's Forces) Exemption Order, 1937.

2. From and after the date of coming into operation of this Order a motor car or a motor cycle the property of an officer of His Majesty's Forces serving in the Colony, not being a motor car or motor bicycle the importation of which into the Colony is prohibited under any law or public instrument in force for the time being, and which is imported by such officer for his own use shall be admitted into the Colony free from all import duties :

Provided that at the time of importation such officer shall sign and deliver to the Comptroller an undertaking that he will export such motor car or motor cycle within twelve months from the importation thereof or within such further period, not exceeding the period of service in the Colony of such officer, as the Comptroller may allow in that behalf, and that failing exportation as aforesaid he will pay the import duties which, but for this Order, would have been payable upon the importation of such motor car or motor cycle.

3. This Order shall be deemed to have commenced and come into operation on the 1st April, 1937.

THE NEWSPAPER, BOOKS AND PRINTING PRESSES LAWS,
1934 TO 1936.

1. This Order may be cited as the Newspaper ("Atlantis") Prohibition Order, 1937.

2. From and after the date hereof the introduction or circulation in the Colony of the Newspaper set out in the Schedule hereto is prohibited.

THE ELEMENTARY EDUCATION LAWS, 1933 TO 1936.

ORDER MADE UNDER SECTION 71.

Whereas His Excellency the Governor has, under section 52 of the Elementary Education Laws, 1933 to 1936, ordered the Town Committees and Village Commissions for Orthodox-Christian Schools mentioned in the second column of the Schedule hereto to provide school buildings, premises, playgrounds, yards, gardens or teachers' dwellings:

And whereas the necessary estimates and plans have been prepared under section 53 of the above-mentioned Laws:

And whereas loans amounting to the sums mentioned in the third column of the Schedule hereto have, under section 51 (1) and (2), been raised to meet the expense of providing such buildings as aforesaid:

Now, therefore, in pursuance of the powers vested in him by section 71 of the Elementary Education Laws, 1933 to 1936, His Excellency the Governor has been pleased to order and it is hereby ordered that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedule hereto be recovered respectively from the church or churches, monastery or throne and the Orthodox-Christian inhabitants of the towns and villages mentioned in the second column of the said Schedule in manner provided by section 72 of the above Laws.
