PROCLAMATION (

MADE UNDER

THE VILLAGE AUTHORITIES LAWS, 1931 TO (No. 2) 1935.

H. R. PALMER, Governor.

Whereas it is expedient to amend the boundaries of the villages of Karavostasi, Lefka and Ambelikou in the District of Nicosia.

Now, therefore, in exercise of the powers vested in me by the Village Authorities Laws, 1931 to (No. 2) 1935, and of every other power and authority enabling me in that behalf, I, Herbert Richmond Palmer, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby proclaim as follows:—

That from and after the 1st day of June, 1937:—

- (a) the area described in the First Schedule hereto, heretofore reckoned within the boundaries of the village of Lefka, shall form part of the lands of the village of Karavostasi and that the boundaries of the said villages of Lefka and Karavostasi be altered accordingly;
- (b) the area described in the Second Schedule hereto, heretofore reckoned within the boundaries of the village of Ambelikou, shall form part of the lands of the village of Karavostasi and that the boundaries of the said villages of Ambelikou and Karavostasi be altered accordingly.

FIRST SCHEDULE.

Area transferred from the village of Lefka to the village of Karavostasi.

The boundary of the area begins on the seashore at the point due north of the north-eastern point of plot No. 203/5 of the Government Survey Village Plan, Karavostasi, and goes eastwards and north-eastwards along the seashore to the mouth of the river "Lefkatis," locality "Paleoalakaton"; thence south-eastwards up this river to the point

at which it is crossed by the Government railway from Kalokhorio to the jetty at Xeros; thence south-westwards along the southern boundary of this railway to the north-western corner of plot No. 46 of the Government Survey Plan XIX/59, locality "Loura"; thence south. westwards passing along the boundaries of, and including, plots Nos. 47/1 and 19/1, 19 of the said plan, plots Nos. 20/3, 25, 27, 26 and 22 of the Government Survey Plan No. XXVIII/2, to the eastern boundary of the Government railway from Xeros to Mavrovouni Mine; thence south. westwards along this boundary of the said railway to the point in which it meets the northern boundary of plot No. 70 of the Government Survey Plan No. XXVIII/2; thence north-westwards, passing along the boundaries of, and including, plots Nos. 40, 18, 15, 16, 17, 10, 6, 5, 4, 1 of the Government Survey Plan No. XXVIII/2, locality "Kambopoli," plots Nos. 65, 66 and 67 of the Government Survey Plan No. XIX/58, to the north-eastern corner of plot No. 203/5 of the Government Survey Village Plan, Karavostasi; thence due northwards in a straight line to the starting point.

The area comprises 1,272 donums or thereabouts and is shown coloured green on the Government Survey Plan, Serial No. 1087, filed in the office of the Director of Land Registration and Surveys in M.P. 534/34.

SECOND SCHEDULE.

Area transferred from the village of Ambelikou to the village of Karavostasi.

The boundary of the area begins at the most northern point, of plot No. 94 of the Government Survey Plan No. XIX/58, locality "Physa," on a track, and goes south-eastwards, southwards and south-westwards, passing along the boundaries of, and including, plots Nos. 94, 93, 92, 89, 88, 87, 86, 85, 84, 82, 81, 78 of the said plan, locality "Teratsia"; thence crossing the main road from Karavostasi to Kambos and including plots Nos. 77, 76, 75 of the said plan, plots Nos. 128, 119, 118, 117, 116, 111, 107, 106 of the Government Survey Plan No. XXVIII/2, locality "Laxia," plots Nos. 105 and 104 of the said plan to the most southern point of the latter plot, on a track from the village of Lefka to the village of Galini; thence north-westwards along this track to its junction with the main road from Karavostasi to Kambos at the most western point of plot No. 141 of the Government Survey Plan No. XXVIII/2, locality "Tishon"; thence crossing this main road and following along a track leading to the ruined church "Ayios Kournoutas" to the junction of tracks at the south-western corner of plot No. 95 of the Government Survey Plan No. XIX/58, locality "Toumballi tou Mavrou"; thence northwards along another track to the starting point.

The area comprises 529 donums or thereabouts, and is shown coloured yellow on the Government Survey Plan, Serial No. 1087, filed in the office of the Director of Land Registration and Surveys in M.P. 534/34.
