THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LEFKONIKO.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1945, and otherwise, the Council of the Municipal Corporation of Lefkoniko hereby make the following bye-laws:—

1. These bye-laws may be cited as the Municipal Corporation (Lefkoniko) (Amendment) Bye-laws, 1947, and shall be read as one with the Municipal Corporation (Lefkoniko) Bye-laws, 1940 to 1947 (hereinafter referred to as the principal Bye-laws), and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Lefkoniko) Bye-laws, 1940 to 1947.

repealed and the following paragraph substituted therefor:-

"(1) The following places are fixed as places at which public carriages not exceeding the number set out against each place shall stand when plying for hire and not actually hired (the exact spots fixed as stands being indicated *in loco* by a poster to that effect):

Provided always that no public carriage shall stand at any place as hereinbefore provided in such a way as to block the entrance of any house or premises situated at any such place or so as to interfere with the peaceful enjoyment of such house or premises by the owner or occupier thereof."

3. The principal Bye-laws are hereby amended by the insertion therein immediately after bye-law 183 of the following chapter and bye-law:—
"Chapter 1a.—Regulations of Traffic.

183.—(1) No person shall, in the road or street below named, lead, ride, drive or take any animal or vehicle in the direction mentioned against the name of such road or street between the portions thereof specified:—

Asphalt road of Famagusta-Nicosia.—The direction leading to Nicosia between the portions delimitated by Soteros coffee-shop on the one hand and on the other by the premises of Mrs. Theano Economidou.

Theodoulou Street.—The direction leading to Chera's shop between the portions delimitated by Soteros Church coffee-shop on the one hand and on the other by the premises of Mrs. Theano Economidou.

(2) The Council shall place sign posts at suitable spots, particularly at points where other streets debouche into the above-named road or street, indicating the direction in which animals and vehicles may move along the above-named road or street."

The above bye-laws have been approved by His Excellency the Governor. (M.P. 984/39/2.)
