THE ARMY ACT.

DECLARATION UNDER SECTION 189 (2).

WINSTER,

Governor,

I, the Governor and Commander-in-Chief of the Colony of Cyprus, in exercise of the powers conferred by section 189 (2) of the Army Act, do hereby declare that, from the date of the signing of the peace treaty with Italy, all British troops serving in Cyprus will remain on active service within the meaning of the said section of the said Act.

This declaration shall remain in force for three months from the date thereof.
