THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE TREASURER UNDER SECTION 6. C. J. THOMAS,

Treasurer.

I, the Treasurer, in exercise of the powers conferred by section 6 of the Trading with the Enemy Laws, 1939 to 1945, (hereinafter referred to as "the Law"), (which renders ineffective, except with my sanction, the transfer by or on behalf of enemies of negotiable instruments and choses in action), do hereby order as follows:-

1. This Order may be cited as the Trading with the Enemy (Transfer

of Negotiable Instruments, etc.) (Austria) Order, 1947.

2. I do hereby sanction-

(a) any assignment of a chose in action which on or after the 13th August, 1946, comes into the ownership of the Government or a person to whom this Order applies;

(b) any transfer of a negotiable instrument issued on or after the

13th August, 1946; and

(c) any transfer of any security transferable by delivery, not being a coupon or a negotiable instrument, which on or after the 13th August, 1946, comes into the ownership of the Government or a person to whom this Order applies,

being an assignment or transfer made on or after the 13th August, 1946, by reason of any trade authorized by clause 2 of the Trading with the Enemy (Authorization) (Austria) Order, 1947, by or on behalf of the Government or person to whom this Order applies.

3. This Order applies-

(a) to the Austrian State;

(b) to any individual resident in Austria;

(c) as respects any business carried on in Austria, to any individual or body of persons (whether corporate or unincorporate) carrying on that business.

4. This Order shall be deemed to have come into operation on the

13th August, 1946.
