**No. 183. THE DEFENCE (HEATERS CONTROL) ORDERS,  
1944 AND 1945.**

**NOTIFICATION UNDER CLAUSE 3 (1).**

In exercise of the powers vested in me under clause 3 (1) of the Defence (Heaters Control) Orders, 1944 to (No. 2) 1945, I hereby declare the 21st July, 1947, to be the date from and after which no person shall erect, use or work within the area of Famagusta district, any wood burning heater of the following type without a licence from me, that is to say:

Kilns for burning gypsum.
