

(2) the payment of any bill of exchange payable in the Colony and drawn before the date of the coming into operation of this Order to or for the benefit of any such person as aforesaid ;

(3) the encashment of any coupons or bonds by or on behalf of any such person as aforesaid.

4. For the purpose of this Order "trade" is confined to supplying any goods to or for the benefit of the states specified in the Schedule hereto or any individual or body of persons (whether corporate or unincorporate) carrying on business therein, or to obtaining goods from such states, individuals or bodies of persons and is deemed to include—

(a) transactions incidental to supplying or obtaining such goods ;
and

(b) the paying, transmitting or receiving of any money, negotiable instrument or security for money in respect of such trade.

5. This Order shall be deemed to have come into operation with regard to—

(a) Hungary, on the 27th August, 1946 ;

(b) Roumania, on the 14th April, 1947.

THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE TREASURER UNDER SECTION 6.

C. J. THOMAS,

Treasurer.

I, the Treasurer, in exercise of the powers conferred by section 6 of the Trading with the Enemy Laws, 1939 to 1945, (hereinafter referred to as "the Law"), (which renders ineffective, except with my sanction, the transfer by or on behalf of enemies of negotiable instruments and choses in action), do hereby order as follows :—

1. This Order may be cited as the Trading with the Enemy (*Transfer of Negotiable Instruments, etc.*) (*Hungary and Roumania*) Order, 1947.

2. I do hereby sanction—

(a) any assignment of a chose in action which comes into the ownership of the Government or a person to whom this Order applies ;

(b) any transfer of a negotiable instrument issued on or after the coming into operation of this Order ;

(c) any transfer of any security transferable by delivery, not being a bond, a coupon or a negotiable instrument, which comes into the ownership of the Government or a person to whom this Order applies,

being an assignment or transfer made by reason of any trade authorized by clause 2 of the Trading with the Enemy (Authorization) (*Hungary and Roumania*) Order, 1947, by or on behalf of the Government or person to whom this Order applies.

3. This Order applies—

- (a) to the states specified in the Schedule hereto ;
- (b) to any individual resident in such states ;
- (c) as respects any business carried on in such states, to any individual or body of persons (whether corporate or unincorporate) carrying on that business.

4. This order shall be deemed to have come into operation with regard to—

- (a) Hungary, on the 27th August, 1946 ;
- (b) Roumania, on the 14th April, 1947.

**THE SHIPS AND AIRCRAFT (TRANSFER RESTRICTION)
ACT, 1939.**

GENERAL SANCTION FOR THE TRANSFER OF CERTAIN SHIPS.

The Governor, in exercise of the power duly delegated to him under the provisions of the Ships and Aircraft (Transfer Restriction) Act, 1939, (hereinafter referred to as "the Act"), has been pleased to give his sanction for the purposes of section 1 (1) of the Act to the transfer between persons entitled to own British ships in accordance with the provisions of section 1 of the Merchant Shipping Act, 1894, of any ship registered in the port of Registry in Cyprus, not being a ship under requisition by or on behalf of His Majesty, to which the Act applies or any share in any such ship, and to the mortgage of any such ship or share therein, and to the transfer of any mortgage of any such ship or share.

Provided that such ship does not exceed 50 tons gross tonnage.
