

No. 218. THE QUARANTINE LAW, 1932.**NOTIFICATION UNDER SECTION 4.**

In exercise of the powers vested in him by section 4 of the Quarantine Law, 1932, or otherwise, His Excellency the Governor is pleased to declare and hereby declares that the local areas in the first column of the Schedule hereto are infected local areas and that all passengers and goods therefrom shall, as from the date hereof, be subject to the measures prescribed by the Quarantine Regulations, 1932 to 1936, with respect to the dangerous infectious diseases in the second column of the Schedule hereto.

The Notification No. 114, published in Supplement No. 3 to the *Gazette* of the 22nd April, 1947, is hereby cancelled.

No. 219. THE ADVOCATES LAWS, 1933 TO 1940.**AUTHORIZATION UNDER SECTION 12 (1).**

No. 220. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.**BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF PAPHOS.**

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1945, and otherwise, the Council of the Municipal Corporation of Paphos make the following bye-laws:—

1. These bye-laws may be cited as the Paphos Municipal (Amendment) Bye-laws, 1947, and shall be read as one with the Paphos Municipal Bye-laws, 1943 to 1946, (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Paphos Municipal Bye-laws, 1943 to 1947.

2. The principal Bye-laws are hereby amended by the insertion therein immediately after bye-law 120 of the following chapter and bye-law :—

“CHAPTER 4A.—*Prophylactic Stations for Venereal Diseases.*”

120A.—(1) No person shall keep or operate a prophylactic station for venereal diseases within the municipal limits without previously obtaining a licence from the Council :

Provided that no licence shall be granted to any person save on production by him of a certificate or other document signed by the Director of Medical and Health Services to the effect that such person is experienced to keep and operate a prophylactic station.

(2) Every such licence shall expire on the 31st day of December next following the date of issue but it shall be subject to renewal yearly if the prophylactic station has been operated to the satisfaction of the medical officer of health.

(3) Any such licence may be revoked at any time by the Council if on good cause shown the Council considers it advisable so to do.

(4) The Director of Medical and Health Services or his representative, the medical officer of health, the Mayor or a representative of the Council authorized in writing in that behalf by the Mayor, shall have the right, and the licensed person shall permit them, to enter and inspect at any time any premises used as a prophylactic station in order to ascertain whether it is properly worked and maintained in the interests of health.”

3. Paragraph (1) of bye-law 214 of the principal Bye-laws is hereby deleted and the following paragraph substituted therefor :—

“(1)—(a) The Council shall charge a duty (hereinafter in this part called ‘entertainment duty’) on all payments made for admission to any public entertainment.

(b) The entertainment duty shall be at the following rates, that is to say :—

(i) On each ticket the total price of which does not exceed 3 piastres	0½
(ii) On each ticket the total price of which exceeds 3 piastres but does not exceed 5 piastres	1
(iii) On each ticket the total price of which exceeds 5 piastres but does not exceed 9 piastres	1½
(iv) On each ticket the total price of which exceeds 9 piastres but does not exceed 13½ piastres	2
(v) On each ticket the total price of which exceeds 13½ piastres but does not exceed 2 shillings	2½
(vi) On each ticket the total price of which exceeds 2 shillings but does not exceed 3 shillings	3
(vii) On each ticket the total price of which exceeds 3 shillings but does not exceed 4 shillings	4
(viii) On each ticket the total price of which exceeds 4 shillings but does not exceed 5 shillings	5
(ix) On each ticket the total price of which exceeds 5 shillings but does not exceed 6 shillings	6
(x) On each ticket the total price of which is over 6 shillings	7

(c) The entertainment duty shall be levied by affixing the seal of the Municipal Corporation on the counterfoil receipts of the tickets of admission.”

4. The principal Bye-laws are hereby amended by the insertion therein after bye-law 248 of the following bye-law :—

“ 248A.—(1) No person shall in the streets below mentioned, lead, ride, drive or take any animal or vehicle in the direction mentioned against the name of each street :—

Thermopilon Street : The direction leading to the junction of Avenue Athinon and Public Offices Road along the whole street.

Part of Avenue Athinon : The direction leading to the junction of Thermopilon Street and Public Offices Street.

Market Street : The direction leading to the entrance of Avenue Athinon.

Afroditi Street : The direction leading to the junction of Market Street and Slaughter-House Street along the whole street.

Fellah Oglou Street : The direction leading to the junction of Fellah Oglou Street and Thermopilon Street at the corner of the premises now occupied by Mr. Panaghiotis Papa Kokkinos, of Paphos.

Miaouli Street : The direction leading to the junction of Fellah Oglou Street and Kanari Street at the corner of the premises now occupied by the Popular Bank.

Kanari Street : The direction from the junction of Kanari Street and Olga Street leading to the junction of Fellah Oglou, Miaouli and Kanari Streets.

Evagoras Street : The direction leading to the junction of Market Street and Evagoras Street along the whole street.

(2) The Council shall place sign posts at suitable spots, indicating the direction in which animals and vehicles may move along the above-named streets.”

The above Bye-laws have been approved by His Excellency the Acting Governor.

THE SUMMER RESORTS (DEVELOPMENT) LAWS, 1938 AND 1946.

BYE-LAWS MADE BY THE SUMMER RESORT DEVELOPMENT BOARD FOR PEDHOULAS.

In exercise of the powers vested in them by the Summer Resorts (Development) Laws, 1938 and 1946, the Summer Resort Development Board for Pedhoulas hereby make the following bye-laws :—

1. These bye-laws may be cited as the *Summer Resort Development (Pedhoulas) (Amendment) Bye-laws, 1947*, and shall be read as one with the *Summer Resort Development (Pedhoulas) Bye-laws, 1939*, (hereinafter referred to as “the principal Bye-laws”), and the principal Bye-laws and these bye-laws may together be cited as the *Summer Resort Development (Pedhoulas) Bye-laws, 1939 and 1947*.

2. Bye-law 148 of the principal Bye-laws is hereby deleted and the following bye-law substituted therefor :—

“ 148.—(1) Any person desiring to carry on, exercise or practise any business, trade, calling or profession within the Summer Resort shall apply to the Board for a licence and the Board shall thereupon decide the business, trade, calling or profession of such person.
