THE CHANGE OF TITLES LAW, 1934.

ORDER IN COUNCIL No. 2255
MADE UNDER SECTION 4.

R. E. TURNBULL,

Acting Governor.

In exercise of the powers vested in the Governor by Section 4 of the Change of Titles Law, 1934, I, the Acting Governor, with the advice of the Executive Council, do hereby order—

(a) that the titles in the First and Second Columns of the First Schedule hereto be added to the First and Second Columns respectively of the First Schedule to the Change of Titles Law, 1934, with effect from the 1st January, 1945;

(b) that the titles in the First and Second Columns of the Second Schedule hereto be added to the First and Second Columns respectively of the Second Schedule to the above-mentioned Law with effect from the same date.

PROCLAMATION MADE UNDER SECTION 22.

R. E. TURNBULL,

Acting Governor.

In exercise of the powers vested in the Governor by section 22 of the Cyprus Volunteer Force Laws, 1940 to 1944, I, Roland Evelyn Turnbull, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do by this Proclamation disband all officers of the Force as from the 31st March, 1947.

DIRECTION UNDER SECTION 10.
