THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF FAMAGUSTA.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1945 and otherwise, the Council of the Municipal Corporation of Famagusta hereby make the following bye-laws :—

1. These bye-laws may be cited as the Famagusta Municipal (Amendment No. 2) Bye-laws, 1947, and shall be read as one with the Famagusta Municipal Bye-laws, 1940 to 1947 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Famagusta Municipal Bye-laws, 1940 to (No. 2) 1947.

2. The principal Bye-laws are hereby amended by the insertion therein immediately after the last paragraph of bye-law 209 (1) of the following paragraphs :—

"EDWARD VIII STREET.—The direction leading from Franklin Roosevelt Avenue throughout the whole street.

HESPERIDES STREET.—The direction leading to Hercules Street between the portions delimitated by Stavros Street on the one hand and on the other by the Stavros Church.

STAVROS STREET.—The direction leading from Plouton Street throughout the whole street.

- SINAN PASHA STREET.—The direction leading from Palace Square between the portions delimitated by Palace Square on the one hand and on the other by the end of Princess Elizabeth Street which is adjoining the Sinan Pasha Street.
- MAHMOUD DJELALEDDIN STREET.—The direction leading from Princess Elizabeth Street between the portions delimitated by Princess Elizabeth Street on the one hand and on the other by Erenler Street."

The above Bye-laws have been approved by His Excellency the Acting Governor. (M.P. 615/12/5.)

THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1943.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF THE VILLAGE OF STYLLOS UNDER SECTION 9.
