

No. 250. THE LAND ACQUISITION LAWS, 1899 TO 1947.**NOTICE UNDER SECTION 5.**

Notice is hereby given that the following lands are required by the Governor for an undertaking of public utility :—

All that area of land situated partly in the town of Larnaca and partly in the village of Livadhia in the district of Larnaca at the localities "Phinikoudhia", "Sykamia" and "Kathari", comprising 191 donums or thereabouts, bounded on the north by marshy ground, on the east by the sea-shore, on the south by a ditch and on the west by the main road from Larnaca to Famagusta and including plots Nos. 76/1 and 165.1 of the Government Survey Plan No. XLI/33, plots Nos. 12/2, 12/1, 12/4 and 12 of the Government Survey Plan No. XLI/41 and plot No. 10 of Block C, Larnaca, more particularly defined as the area coloured red on the plan marked "Electrification Scheme" and dated 11th July, 1947, deposited with the Commissioner, Larnaca.

The said area has been demarcated by four white cairns marked respectively "A", "B", "C" and "D".

2. Any person claiming to have any right or interest in the said lands is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Larnaca.
