## THE VILLAGE AUTHORITIES LAWS, 1931 TO (No. 2) 1937.

## THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Mashera Water of Ayios Ioannis in the District of Limassol, are published in the *Gazette*.

IRRIGATION DIVISION OF MASHERA WATER OF AYIOS IOANNIS.

*Rules.*

1. These rules may be cited as the Irrigation Division of Mashera Water of Ayios Ioannis (Amendment) Rules, 1947, and shall be read as one with the Irrigation Division of Mashera Water of Ayios Ioannis Rules, 1933 and 1938 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Division of Mashera Water of Ayios Ioannis Rules, 1933 to 1947.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "fifteen shillings" and the substitution therefor of the words "five pounds".
