GRANT MADE BY THE ACTING GOVERNOR UNDER SECTION 5.

No. 306. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

In exercise of the powers conferred on the Governor by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1947, I, the Acting Governor, do hereby declare the extension of the buildings and playgrounds of the Secondary School in the town of Nicosia known as the Pancyprian Gymnasium to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Chairman of the Nicosia Town Committee for Greek-Orthodox Schools, in his capacity as Chairman of the governing body of the Greek-Orthodox Secondary Schools in the town of Nicosia, the supervision and effectuation of the said undertaking, the cost whereof shall be borne by the governing body hereinbefore mentioned.

(The Nicosia Town Committee for Greek-Orthodox Schools, in its capacity as the governing body of the Greek-Orthodox Sccondary Schools in the town of Nicosia, has been recognized as a public body for the purposes of the above-mentioned Laws under Notification No. 109 published in Supplement No. 3 to the *Gazette* of the 14th May, 1941).

No. 307. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1947.

ORDER MADE UNDER SECTION 71.

Whereas His Excellency the Governor has, under section 52 of the Elementary Education Laws, 1933 to 1947, ordered the Town Committees and Village Commissions for Greek-Orthodox Schools mentioned in the second column of the Schedule hereto to provide school buildings, premises, playgrounds, yards, gardens or teachers' dwellings:

And whereas the necessary estimates and plans have been prepared under section 53 of the

above-mentioned Laws:

And whereas loans amounting to the sums mentioned in the third column of the Schedule hereto have, under section 51 (1) and (2), been raised to meet the expense of providing such

buildings as aforesaid:

Now, therefore, in pursuance of the powers vested in him by section 71 of the Elementary Education Laws, 1933 to 1947, His Excellency the Acting Governor has been pleased to order and it is hereby ordered that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedule hereto be recovered respectively from the church or churches, monastery or throne and the Greek-Orthodox inhabitants of the towns and villages mentioned in the second column of the said Schedule in manner provided by section 72 of the above Laws.
