the term ‘wholesale’ means sale or purchase of pure ground coffee  
in quantities in excess of 5 okes at any one time or at any  
single transaction.”

## THE FORESHORE PROTECTION LAW, 1934.

## NOTICE UNDER SECTION 3.

In exercise of the powers vested in me by the Foreshore Protection Law, 1934, I do hereby give notice that :—

- (1) except under a written permit from me and under such conditions as I may think fit to impose thereby, the removal of stones, shingle, gravel, sand or other substance from all that area of foreshore described in the Schedule hereto, is absolutely prohibited;
- (2) the dumping of any rubble, rubbish, sweepings, litter, night-soil or other refuse upon any part of the foreshore described in the Schedule hereto, is absolutely prohibited.

## SCHEDULE.

The Foreshore commences at the most northern point of Plot No. 21 of the Government Survey Plan No. XXVI/6, locality “Ayios Elias Church” and proceeds eastwards and south-eastwards along the northern and eastern boundary of the said plot to the south-western corner of Plot No. 24 of the said plan on the right bank of a river; thence south-westwards in a straight line across the said river to the north-western point of Plot No. 61 of the

said plan ; thence southwards along the eastern boundary of Plot No. 83 of the said plan to the south-western corner of Plot No. 131 of the said plan on the right bank of the river " Xeropotamos " ; thence southwards in a straight line across the said river to the north-western corner of Plot No. 143 of the said plan ; thence southwards along the eastern boundary of Plot No. 144 of the said plan to the most western point of Plot No. 150 of the said plan on the right bank of a river ; thence south-westwards in a straight line across the said river to the most northern point of Plot No. 9 of the Government Survey Plan No. XXVI/14 ; thence southwards along the eastern boundaries of Plots Nos. 1, 239/2/1 of the said plan, Plot No. 279. 1 of the Government Survey Plan No. XXVI/22 to the south-western corner of Plot No. 3 of the said plan on the right bank of a river ; thence westwards along the said bank of the river to the seashore, as shown on the map kept in the office of the Commissioner, Paphos, and extends inland to a depth of 50 yards from high water mark throughout its length.
