THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

ORDER IN COUNCIL No. 2267

MADE UNDER SECTION 116 (a) (i).

Authority to the Council of the Municipal Corporation of Limassol to contract a loan.

In exercise of the powers vested in me by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1945, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Limassol (hereinafter referred to as "the Municipal Corporation") shall be at liberty to borrow from the People's Bank Limassol, Limited, (hereinafter referred to as "the Lender") the sum of thirteen thousand five hundred pounds (£13,500) at a rate of interest not exceeding three and one quarter per centum ($3\frac{1}{4}\%$) per annum, subject to the following terms and conditions, that is to say—

- (a) that during each of the first two years only the interest on the sum borrowed shall be paid;
- (b) that thereafter the sum borrowed shall be repayable by the Municipal Corporation to the Lender in ten equal annual instalments (comprising sinking fund and interest);
- (c) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on the revenues the sums payable as aforesaid in the year to which such estimates relate;
- (d) that the sum borrowed shall be utilized by the Municipal Corporation for—
 - (i) constructing eleven kiosks at suitable places in the town of Limassol;
 - (ii) constructing an underground building to be used by the Municipal Corporation as a coffee-shop or for other purposes, together with a Monument thereon;
 - (iii) constructing five shops on municipal property situate in front of the main entrance to the A'. Municipal Market;
 - (iv) converting the existing large municipal coffee-shop, situate near the A'. Municipal Market, into a smaller coffee-shop and a shop;

- (v) providing a roof to the open space belonging to the Municipal Corporation and situate east of the A'. Municipal Market (now stalls for the sale of pork) and converting such space into a Fish Market and into stalls for use by producers ;
- (vi) providing a roof to the incomplete municipal shop situate north-east of the A'. Municipal Market and converting such shop into a Pork Market ;
- (vii) effecting general repairs to the large municipal hall situate north of the A'. Municipal Market and converting such hall into a restaurant or into a hall for festivities :

Provided that, unless the Colonial Secretary otherwise directs in writing, all work shall be done by contract and made the subject of public tender and that the final plans and contracts will be subject to the approval of the Divisional Engineer, Limassol :

Provided further that in connection with item (ii) above the amount to be spent out of the sum borrowed on the Monument alone shall not exceed the equal of the sum which the Municipal Corporation may secure by public subscription in this respect, the cost of such Monument however not exceeding £1,000 in the aggregate.

2. That, for the purpose of securing the repayment of the sums due under the loan, the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

THE MISSIONARY EDUCATIONAL AND MEDICAL (ALIEN REGULATION) LAWS, 1922 AND 1933.

PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, the persons whose names appear in the Schedule hereto have applied for a permit under the provisions of the said Laws ;

And whereas the said persons have severally given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, that they desire and purpose *ex animo* to work in friendly co-operation with the said Government in all matters in which their influence might properly be exerted ; and, in particular, they have undertaken that if engaged in educational work, their influence will be exerted to promote loyalty to the Government of Cyprus in the minds of their pupils and to make them good citizens of the British Empire ;

Now, therefore, I, the Governor in Council, in exercise of the powers conferred by section 8 of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, do hereby grant to the persons whose names appear in the Schedule hereto a permit to commence or carry on the work set down after their names.
