NOTICE UNDER SECTION 5.

Notice is hereby given that the following lands are required by the

Governor for an undertaking of public utility:—

THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1943.

Rules made by the Village Health Commission of the Village of Moutayiaka under Section 9.

In exercise of the powers vested in them by Section 9 of the Public Health (Villages) Laws, 1936 to 1943, the Village Health Commission of Moutayiaka hereby make the following rules:—
