

No. 357.**THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.****ORDER MADE UNDER SECTION 13 (2).**

In exercise of the powers vested in the Governor by section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936, and duly deputed to me by the Delegation published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I do hereby order that the Order relating to the Tree Planting Area of the village of Ayia Varvará published in Supplement No. 3 to the *Gazette* of the 20th August, 1937, shall be extended for a further period of five years from the date of the expiration thereof.

2. This Order shall be deemed to have come into force on the 18th day of September, 1947.

No. 358. THE LAND ACQUISITION LAWS, 1899 TO 1947.**NOTICE UNDER SECTION 5.**

Notice is hereby given that the following lands are required by the Governor for an undertaking of public utility :—

All that area of land situated in the village of Pyla in the district of Larnaca at the locality " Filino " comprising 223 donums or thereabouts bounded on the west by private property, on the north and east by Crown land and private property and on the south by Crown land adjoining the sea-shore and including plots Nos. 78 (partly), 77, 76, 70, 67/1, 68, 69 (partly), 63 (partly), 65, 66, 71, 72, 74, 75, 88/1, 88/2, 89 and 90 of the Government Survey plan XLI/20, more particularly defined as the area edged yellow on the plan marked " Dhekelia Military Camp Site " and dated 23rd September, 1947, deposited with the Commissioner, Larnaca. The said area is being used as the site of the Dhekelia Military Camp. (The road from Larnaca to Ormidhia is excluded from the area to be acquired).

Any person claiming to have any right or interest in the said lands is required within 10 days from the date of the notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Governor is willing to treat for the acquisition of the said lands.

A plan showing the lands described above is available for inspection at my office in Larnaca.

NOTE.—The abridgment of the period to 10 days has been approved by His Excellency the Acting Governor.

No. 359.**THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1943.****RULES MADE BY THE VILLAGE HEALTH COMMISSION OF THE VILLAGE OF MOUTAYIAKA UNDER SECTION 9.**

In exercise of the powers vested in them by Section 9 of the Public Health (Villages) Laws, 1936 to 1943, the Village Health Commission of Moutayiaka hereby make the following rules :—

1. These rules may be cited as the Village Health (Moutayiaka) Rules, 1947, and shall come into operation on their publication in the *Gazette*.
