No. 375. THE CYPRUS PENSIONS ORDERS AND LAWS, 1929 TO (No. 2) 1946.

REGULATIONS MADE UNDER SECTION 3.

In exercise of the powers vested in the Governor by section 3 of the Cyprus Pensions Orders and Laws, 1929 to (No. 2) 1946, I, the Acting Governor, with the advice of the Executive Council and with the sanction of the Secretary of State, do hereby make the following regulations :--

1. These regulations may be cited as the Cyprus Pensions (Amendment) Regulations, 1947, and shall be read as one with the Cyprus Pensions Regulations, 1929 to (No. 2) 1946, (hereinafter referred to as the principal Regulations ") and the principal Regulations and these Suppl. No. 3: regulations may together be cited as the Cyprus Pensions Regulations, 1929 to 1947.

> 2. The principal Regulations are hereby amended by the insertion therein immediately after regulation 9 of the following regulation :---

"Service as schoolteacher followed by other service.

9A.—(1) Notwithstanding anything in these Regulations contained, when a person who, having served as a teacher in any elementary school operating under the provisions of any law in force for the time being from and after the commencement of the Education Law, 1905, is appointed without any break to the service of the Government, any period of service as such teacher shall be taken into account for the purposes of these Regulations:

Provided that-

- (a) notwithstanding any break between service as such teacher and appointment to the service of the Government, any period of service as such teacher as hereinbefore provided, may, with the approval of the Governor, be also taken into account regard being had to the circumstances in which such break occurred;
- (b) of the service before the 1st October, 1920, in the case of a Moslem teacher and of the service before the 1st September, 1923, in the case of a Greek-Orthodox teacher, only two-thirds shall be counted for the purposes of these Regulations;
- (c) such person, upon his appointment to the pensionable service, shall refund any gratuity, benevolent grant or additional grant received by him in respect of his service as such teacher : Provided that any person appointed to the pensionable service before the publication of these Regulations in the Gazette shall make the refund not later than the 30th June, 1948.

(2) This regulation shall be deemed to have been made and to have come into operation on the 1st day of September, 1945 ".

3. Regulation 17 of the principal Regulations is hereby further amended by the insertion therein immediately after the words "Evcaf Department in Cyprus" of the words "and the Imperial Bureau of Animal Breeding and Genetics".
