No. 380. THE LAND ACQUISITION LAWS, 1899 TO 1947.**NOTICE UNDER SECTION 5.**

Notice is hereby given that the following lands are required by the Governor for an undertaking of public utility:—

All those two areas of land, with the trees and spring standing thereon, situated in the village of Kannavia in the District of Nicosia at the localities "Kapoura" and "Ayios Ionisis", near the Kapoura Forest Station, comprising together 13¼ donums or thereabouts, the one bounded on the west by the "Kannavia River", on the north by the Adelphi Forest, on the east by a road and on the south by the Adelphi Forest, the other bounded on the west by the "Kannavia River" and on the north, east and south by the Adelphi Forest, being plots Nos. 75/1 and 75/2 of the Government Survey Plan No. XXXIII. 1, more particularly defined as the areas coloured red on the plan marked "A" and dated 20th November, 1947, deposited with the Commissioner of Nicosia.

2. Any person claiming to have any right or interest in the said lands is required within 6 weeks from the date of the notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Nicosia.
