

**No. 44.****THE CRIMINAL EVIDENCE AND PROCEDURE LAWS, 1929 TO 1934.****AUTHORIZATION UNDER SECTIONS 3 AND 5A.**

By virtue of the powers vested in the Governor by sections 3 and 5A of the Criminal Evidence and Procedure Laws, 1929 to 1934, I hereby authorize—

- (1) Apostolos Christoforou, Dispenser, and
  - (2) Christos M. Ioannides, Dispenser,
- to hold enquiries into the commission of offences against :—
- (a) the Pharmacy and Poisons Law, 1945, and the Regulations made thereunder ;
  - (b) the Dangerous Drugs Laws, 1925 to 1932, and the Regulations made thereunder ;
  - (c) the Sale of Food and Drugs Law, 1938, and the Regulations made thereunder ;
  - (d) the Medical Registration Laws, 1936 to 1943 ;
  - (e) any Order of the Controller of Medical Supplies made or having effect under the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

2. The Authorizations published under Notifications Nos. 77 and 438 in Supplement No. 3 to the *Gazettes* of the 19th March, 1942, and the 2nd December, 1943, respectively, are hereby cancelled.

**No. 45. THE ADVOCATES LAWS, 1933 TO 1940.****AUTHORIZATION UNDER SECTION 12 (1).**

I, the Attorney-General, in exercise of the powers conferred by section 12 (1) of the Advocates Laws, 1933 to 1940, do hereby authorize—

- (e) any Order of the Controller of Medical Supplies made or having effect under the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

2. The Authorizations published under Notifications Nos. 76 and 439 in Supplement No. 3 to the *Gazettes* of the 19th March, 1942, and the 2nd December, 1943, respectively, are hereby cancelled.
