THE TRADES AND INDUSTRIES (REGULATION) LAWS,

ORDER IN COUNCIL No. 2232

MADE UNDER SECTION 3.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 3 of the Trades and Industries (Regulation) Laws, 1937 and 1942, do hereby order as follows:—

1. This Order may be cited as the Trades and Industries (Regulated Trade Areas) Order, 1947.

2. Every district, sub-district, area, town, village, quarter or place in the Colony is hereby declared to be a regulated trade area for the purposes of the Trades and Industries (Regulation) Laws, 1937 and 1942.

3. This Order shall come into operation on the 15th day of September, 1947, and, thereupon, the Trades and Industries (Regulated Trade Areas) Order, 1937, shall be revoked.
