**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)**  
**(CYPRUS) ORDER, 1946.**

**ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE**  
**REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I hereby order as follows :—

1. This order may be cited as the Defence (Control of Slaughter of Cattle) Amendment Order, 1947, and shall be read as one with the Defence (Control of Slaughter of Cattle) Order, 1946, (hereinafter referred to as "the principal Order"), and the principal Order and this order may together be cited as the Defence (Control of Slaughter of Cattle) Order, 1947.
2. The principal Order is hereby amended by the deletion therefrom of clause 2 and the substitution therefor of the following clause :—

"2. In this order—  
 'Cattle' means a cow or heifer."

3. This order shall be deemed to have come into operation on the 21st day of December, 1946.

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)**  
**(CYPRUS) ORDER, 1946.**

**ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE**  
**REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) Order, 1946, I hereby order as follows :—

1. This order may be cited as the Supplies and Services (Control of Slaughter of Lambs) Order, 1947.

2.—(1) No person shall—

- (a) slaughter any lamb weighing less than seven and a half okes ;
- (b) have in his possession the carcass of a lamb weighing less than five okes.

(2) For the purpose of this paragraph the term "carcass" means the whole of the skinned carcass with the lungs, heart, liver and kidneys but without the other viscera.

3. I may appoint inspectors and the Commissioner of each District shall, if so required by me, appoint inspectors to ascertain whether the provisions of this order have been or are being complied with and every inspector so appointed shall have power to enter at all times, at reasonable hours, upon any premises for the purpose of carrying out any inspection or search which may be reasonably required in order to ascertain whether the provisions of this order have been or are being complied with.

4. Any person who acts in contravention of, or fails to comply with, any of the provisions of this order is liable to the penalties prescribed in the Defence Regulations, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

5. This order shall come into operation on the 4th day of January, 1947.
