

(4.) An alien with respect to whom a deportation order is made may be detained in such manner as may be directed by the High Commissioner and may be placed on a ship about to leave Cyprus and shall be deemed to be in legal custody whilst so detained, and until the ship finally leaves Cyprus.

(5.) The master of a ship about to call at any port outside Cyprus shall, if so required by the High Commissioner, or by an immigration officer, receive an alien against whom a deportation order has been made, and his dependents, if any, on board the ship, and afford him and them a passage to that port and proper accommodation and maintenance during the passage.

Saving for  
diplomatic  
persons, etc.

6. Nothing in this Law contained shall be construed as imposing any restriction or disability on any duly accredited head of a foreign diplomatic mission or any member of his official staff or household.

Offences and  
penalties.

7.—(1.) If any person acts in contravention of or fails to comply with the provisions of this Law or any order made thereunder, he shall be guilty of an offence against this Law.

(2.) If any person aids or abets any person in any contravention of this Law, or knowingly harbours any person whom he knows or has reasonable ground for believing to have acted in contravention of this Law, he shall be guilty of an offence against this Law.

(3.) Where a person lands in Cyprus in contravention of this Law the master of the ship or the pilot or commander of the aircraft from which he lands shall, unless he proves to the contrary, be deemed to have aided and abetted the offence.

(4.) A person who is guilty of an offence against this Law shall be liable to a fine not exceeding one hundred pounds or to imprisonment, with or without hard labour, for a term not exceeding six months, or, on a second or subsequent conviction, twelve months, or, in either case, to both such fine and imprisonment.

TO PROVIDE FOR THE SUPERVISION OF MISSIONARY EDUCATIONAL OR  
MEDICAL WORK BY PERSONS OF ALIEN NATIONALITY.

Short title.

1. This Law may be cited as the Missionary Educational and Medical (Alien Regulation) Law, 1922.

## 2. In this Law :—

Definition.

A “ recognized society ” means a Christian society or organization which the High Commissioner in Council may by order declare to be a recognized society for the purposes of this Law.

3. Every missionary or employé or member of a recognized society not in communion with the Church of Rome, the Orthodox Church, or other Oriental Churches, who is not a British subject, shall, before he shall commence or continue his work in Cyprus, transmit to the Chief Secretary to the Government a document of guarantee in the form prescribed by the Conference of Missionary Societies in the United Kingdom or by the Foreign Missions Conference of North America, as the case may be, and duly signed or countersigned by an official of the Conference concerned duly authorized in that behalf. Provided always that the High Commissioner may by a permit under his hand and for such period as he may prescribe allow any such missionary or employé or member already engaged in such work in Cyprus to continue such work pending the receipt of the said document of guarantee.

Recognized societies not in communion with the Church of Rome, the Orthodox Church or other Oriental Churches.

4. Every missionary or employé or member of a recognized society in communion with the Church of Rome, who is not a British subject, shall, before he shall commence or continue his work in Cyprus, transmit to the Chief Secretary to the Government a document of guarantee in the form prescribed by the Cardinal Archbishop of Westminster and signed by the Superior of the House of the society in the United Kingdom and countersigned by an authority duly nominated in that behalf by the Cardinal Archbishop of Westminster: provided always that the said Superior of the House of the society in the United Kingdom shall be a natural born British subject. Provided always that the High Commissioner may by a permit under his hand and for such period as he may prescribe allow any such missionary or employé or member already engaged in such work in Cyprus to continue such work pending the receipt of the said document of guarantee.

Recognized societies in communion with the Church of Rome.

5. The High Commissioner in Council may by order from time to time add to the societies declared to be recognized societies and may declare any society no longer to be a recognized society.

Recognized societies may be added or declared no longer to be recognised societies.

6. In the event of a recognized society ceasing to be a recognized society any document of guarantee granted as provided in sections 3 and 4 shall be deemed to have been made void and of no effect.

Document of guarantee to become void if society ceases to be a recognized society.

Permit necessary for alien not belonging to a recognized society to commence philanthropic, educational or medical work.

7. Every person, not being a British subject, or not being a missionary or employé or member of a recognized society, whatever his religious belief, before he shall commence or continue any philanthropic, educational or medical work (whether he is a missionary or attached to a religious mission or not, and whether the mission or philanthropic enterprise with which he is associated or with which he desires to associate himself is a secular or religious body), shall obtain a permit in such terms as the High Commissioner in Council may prescribe and shall also give an undertaking to co-operate loyally with the Government of Cyprus in the form set forth in the Schedule hereto or in such other form as the High Commissioner in Council may prescribe.

Application for and grant of permit.

8. An application for a permit shall be made in such manner as the High Commissioner may by notice prescribe and the High Commissioner in Council may grant or refuse any such permit.

Cancellation or modification of permit.

9. A permit may be cancelled or modified by order of the High Commissioner in Council.

Inspection.

10. Any school or other institution maintained by any recognized society or any person under a permit under this Law may be inspected by the High Commissioner or such person as he may appoint in order to ensure that the spirit of such school or other institution is satisfactory.

## SCHEDULE.

### FORM OF UNDERTAKING.

I, \_\_\_\_\_, hereby undertake to pay all due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, I desire and purpose *ex animo* to work in friendly co-operation with the said Government in all matters in which my influence may properly be exerted; and in particular, I undertake, if engaged in educational work, that my influence shall be exerted to promote loyalty to the Government of Cyprus in the minds of my pupils, and to make them good citizens of the British Empire.
