1. This Law may be cited as the Marriage (Amend- short title. ment) Law, 1925, and shall be read as one with the Marriage Law, 1922, (hereinafter referred to as the Principal Law) and the Principal Law and this Law may together be cited as the Marriage Laws, 1922 and 1925.

2. The Principal Law, section 4, shall be amended by the deletion of the words "no step shall be taken to include or remove any such minister" and the substitution therefor of the following words:

3. The Principal Law, section 19, is hereby repealed 1922, sec. 19. and the following section substituted therefor:

> 19. Where a marriage is celebrated by a registered minister of persons who are not members of the same Church, the parties thereto shall within fifteen days of such celebration of marriage appear before a marriage officer and effect registration thereof. Any person who, being a party to such marriage, fails without reasonable excuse to register a marriage within the period aforesaid shall be liable to a penalty not exceeding ten pounds, provided always that the marriage officer shall proceed to register such marriage in accordance with the Law.
