Penalties.

14. Any person who-

- (a) acts in contravention of section 5, 6 or 7 of this Law; or
- (b) obstructs in the lawful execution of his duty any Police officer authorized to act under section 10 of this Law,

shall be guilty of an offence and shall be liable to a fine not exceeding fifty pounds and the Court may order that any film or poster in respect of which such offence has been committed shall be forfeited.

Saving.

Date of coming into operation and repeal of Law 45 of 1933. 15. Any cinematograph film in respect of which a permit has been obtained from the Board established under the Order in Council, No. 1485, made the 5th day of August 1932, and published in the *Cyprus Gazette* of the 12th August, 1932, shall be deemed to be a cinematograph film approved and marked by a Censorship Committee under the provisions of this Law.

16. This Law shall come into operation on a day to be fixed by the Governor by notice published in the *Cyprus Gazette* and thereupon the Cinematograph Films Law, 1933, shall be repealed.

## BE it enacted :--

Short title.

18 of 1932. 13 of 1934. 1. This Law may be cited as the Immovable Property Tax (Amendment No. 2) Law, 1934, and shall be read as one with the Immovable Property Tax Laws, 1932 and 1934, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Immovable Property Tax Laws, 1932 to 1934.

2. Section 5A of the Principal Law is hereby repealed and Repeal of the following substituted therefor:-

" Fower to Governor in Council to increase Immovable Property Tax.

5A. The Governor in Council may by Order Law and or Orders to be published in the Cyprus Gazette substitution direct that the rate of Immovable Property Tax section. payable in respect of immovable property owned by any person-

(a) within the limits of any town or quarter of a town;

(b) within the limits of any village or quarter of a village,

shall be increased in any year by such amount or amounts not exceeding in either case one per thousand on the capital value of such immovable property as assessed in faw 20/42 accordance with the provisions of this Law, as may be directed in such Order or Orders and any such increase shall be collected and paid in the same manner and at the same time as the Immovable Property Tax payable thereon."

This Law came into operation on 14th December, 1934.
