THE STATUTE LAWS OF CYPRUS

No. 24 of 1952.

A Law to enable effect to be given to the provisions of certain Treaties of Commerce and Navigation in regard to the Administration of the Estates of Deceased Foreigners by Consular Officers.

WHEREAS it is expedient that effect should be given in the Colony to the provisions of certain Treaties of Commerce and Navigation mentioned in the Schedule hereto:

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows:—

- 1. This Law may be cited as the Administration of Estates Short title. by Consular Officers Law, 1952.
- 2. Whenever any subject or citizen of any State mentioned Administration of the first column of the Schedule hereto—

 Administration of estates by

(a) dies within the Colony, or

(b) dies outside the Colony, leaving property within Schedule. the Colony,

and no person is present in the Colony at the time of his death who is rightfully entitled to administer the estate

of such deceased person, the Consul, Vice-Consul, or Consular Agent of such State within the Colony may take possession and have the custody of the property of such deceased person, and may apply the same in payment of his debts and funeral expenses, and may retain the surplus for the benefit of the persons entitled thereto; but such Consul, Vice-Consul, or Consular Agent shall immediately apply for, and shall be entitled to obtain from the Court, Letters of Administration of the property of such deceased person, limited in such manner and for such time as to the Court shall seem fit.

Variation of Schedule.

3. It shall be lawful for the Governor by Order published in the Gazette to vary the Schedule by deleting therefrom any State when the provision of the Treaty with that State mentioned in the Schedule shall have ceased to have effect,
