

Power to Governor to order appropriation of any sum of money in respect of guarantee.

Repeal of Law 11 of 1925 and Law 24 of 1928 and saving.

3. The Governor may, from time to time, and as occasion may require, order that a sum of money be appropriated out of the general revenues of the Colony of Cyprus to meet any liability due under any guarantee given under section 2 of this Law.

4. The Agricultural Bank of Cyprus Limited Guarantee Law, 1925, and the Agricultural Bank of Cyprus Limited Guarantee (Amendment) Law, 1928, are hereby repealed. Provided that any agreement entered into by virtue of and referring to the Laws hereby repealed shall be construed to refer to this Law or to the corresponding enactment in this Law.

BE it enacted :—

Short title.

1. This Law may be cited as the Agricultural Bank of Cyprus Limited Guarantee (Amendment) Law, 1929, and shall be read as one with the Agricultural Bank of Cyprus Limited Guarantee Law, 1929, (hereinafter referred to as the Principal Law), and the Principal Law and this Law may together be cited as the Agricultural Bank of Cyprus Limited Guarantee Laws, 1929.

Amendment of Law 1 of 1929, sec. 2 (2).

2. The Principal Law, section 2 (2), is hereby amended by the deletion of the words "any sum not exceeding two hundred thousand pounds raised by an issue of bonds" and the substitution therefor of the words "bonds of an aggregate nominal value of two hundred thousand pounds issued".

3. This Law shall be deemed to have commenced and come into operation on the 18th day of January, 1929. Date of coming into operation.

BE it enacted :—

1. This Law may be cited as the Government Savings Bank (Repeal) Law, 1929. Short title.

2. From and after the 1st day of January, 1930, the Government Savings Bank Law, 1900, and the Government Savings Bank (Amendment) Law, 1926, shall be repealed. Provided that any deposits made pursuant to the Laws hereby repealed up to the 31st day of December, 1929, may be withdrawn at any time after the said date by the persons entitled thereto, but such deposits shall bear no interest after the said date. Repeal of certain enactments and saving.
