A LAW TO AMEND THE CUSTOMS LAWS, 1936 TO (No.2) 1945.

**B**E it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :—

1. This Law may be cited as the Customs (Amendment) Law, 1946, and shall be read as one with the Customs Laws, 1936 to (No.2) 1945, (hereinafter referred to as "the principal Law"), and the principal Law and this Law may together be cited as the Customs Laws, 1936 to 1946.

2. Sub-section (1) of section 34 of the principal Law is hereby amended by the insertion therein at the end thereof of the following proviso :—

" Provided that whenever an exemption in the Second Schedule makes reference to the particular use to which

an exempted article may be put, the Comptroller may refuse free importation if he is of opinion that the article will be used for some purpose other than the purpose therein referred to or he may impose such conditions for the use of such article as to him may seem fit, including the giving of security by the importer, in order to ensure that the article will be put solely to the use for which its free importation was permitted."

3. Section 66 of the principal Law is hereby amended by the deletion of the fullstop at the end thereof and the insertion therein of the following:—

"and for the warehousing and securing of wines and spirits for exportation."

4. The First Schedule to the principal Law (as set out in Law 10 of 1940) is hereby amended by the addition immediately after the word "preserved" in item 75 thereof of the following:—

", and milk foods."

5. The Second Schedule to the principal Law is hereby amended as follows:—

(a) by the insertion in item 9 immediately after the first paragraph, ending with the words "the arrival of such passenger", of the following proviso:—

"Provided that, in any special case where, for reasons beyond the control of the passenger, such baggage is not imported within the aforementioned period after the arrival of such passenger, the Colonial Secretary may, if he deems fit, extend this period for a further period not exceeding six months."

(b) by the deletion therefrom of item 32A (as set out in section 10 of Law 34 of 1938) and the substitution therefor of the following item:—

"32A. Essences for the manufacture of perfumery."

(c) by the insertion therein immediately after item 77 of the following item:—

"77A. Pyrethrum flowers."
